Memorandum of Understanding (MoU)

This Memorandum of Understanding (MoU) is made on this 16th day of
June, 2022,

Between:

Government Degree College, Rayachoty hereinafter referred to as "GDC
Rayachoty," represented by its Principal, Dr. Harshalatha,

AND

Sri Lakshmi Narasimha Medical Agencies, located at Gandhi Road, Rayachoty,
hereinafter referred to as "Sri Lakshmi Narasimha Agencies,"

collectively referred to as "Parties."

Purpose

The purpose of this MoU is to establish a collaborative relationship between GDC Rayachoty and Sri Lakshmi Narasimha Agencies to provide students with practical experience and training in retail and business management. This partnership aims to facilitate internships, field visits, workshops, and knowledge transfer for the students of GDC Rayachoty.

Scope of Collaboration

Internships

Sri Lakshmi Narasimha Agencies agrees to offer short-term and long-term internships to students from relevant disciplines at GDC Rayachoty.

The internships will provide hands-on experience in retail operations, customer service, inventory management, and sales strategies.

The selection process and number of interns will be mutually determined by both Parties.

Field Visits

Sri Lakshmi Narasimha Agencies will facilitate field visits for GDC Rayachoty students to gain exposure to retail operations, supply chain management, and business practices.

The schedule and number of field visits will be decided in coordination with GDC Rayachoty.

Workshops and Training Programs

Both Parties will collaborate to organize workshops and training programs focused on retail management, customer relationship management, and business development.

Experts from Sri Lakshmi Narasimha Agencies will be invited to conduct these sessions at GDC Rayachoty.

Knowledge Exchange

The partnership will include knowledge exchange initiatives, such as guest lectures, seminars, and collaborative projects.

Roles and Responsibilities

GDC Rayachoty:

Identify and nominate students for internships and field visits.

Coordinate with Sri Lakshmi Narasimha Medical Agencies to plan and schedule the agreed activities.

Ensure that participating students adhere to the rules and protocols of Sri Lakshmi Narasimha Medical Agencies.

Sri Lakshmi Narasimha Agencies:

Provide necessary facilities and guidance to students during internships and field visits.

Assign mentors to oversee the students' progress and provide feedback.

Ensure a safe and educational environment for students.

Duration

This MoU will be effective for a period of three years from the date of signing, with the possibility of renewal upon mutual agreement.

Termination

Either Party may terminate this MoU with 30 days' written notice. Upon termination, both Parties agree to complete any ongoing activities.

Confidentiality

Both Parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the collaboration.

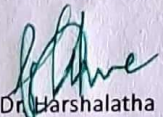
Amendments

Any amendments to this MoU must be made in writing and signed by both Parties.

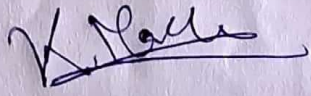
